Data and information supporting the GHG emissions assertion were historical in nature, representing actual measurements and records from the operational activities of **ETHYDCO** during the specified period.

This verification was conducted in accordance with the ISO 14064 -3 standard.


#### 5 Decision on the Claim

No unresolved findings were identified during the verification process. All discrepancies and issues noted during the verification were resolved prior to the issuance of this statement.


