6.	Description of content: This Ministerial Decree provides producers and importers a transitional period of six months to comply with the modified Egyptian standard ES 495-2/2015 "Office Furniture – Office Work Chair – Part 2: Safety Requirements".
	This Egyptian standard is to determine the safety requirements for the purpose of office chairs – set operating requirements for 8 hours a day, weighing up to 110 kilograms. For the purpose of hard working conditions additional requirements are added.
	It complies with BS /EN 1335-2/2009 Office Furniture – Office Work Chair – Part 2: Safety Requirements.
