- **Description of content:** The Ministerial Decree mandates that the producers and importers must comply with ES 7883/2015. Producers and importers are given a transitional period of six months.

This standard applies to Uniform provisions concerning the approval of:

- Vehicles with regard to limitation of their maximum speed or their adjustable speed limitation function
- 2. Vehicles with regard to the installation of a speed limiting device (SLD) or adjustable speed limitation device (ASLD) of an approved type
- 3. Speed limitation devices (SLD) and adjustable speed limitation device (ASLD)
