Producers and importers are given a transitional period of six months. These standards applies to: (Bulbs) LED lamps 1. ES 7773/2014 applies to Self-ballasted LED lamps for general lighting services with supply voltages > 50 V – Performance requirements. 2. ES 7774/2014 applies to Self-ballasted LED-lamps for general lighting services by voltages > 50 V – Safety specifications These standards comply with IEC 62612 and IEC 62560.
