| 6. | <b>Description of content:</b> This Ministerial Decree mandates that the producers and importers must abide by ES7934/2015. Producers and importers are given a twelve months transition period to abide by the standard.<br><br>This standard applies to motor vehicle headlamps, which may incorporate lenses of glass or plastic material.<br><br>Worth mentioning is that this standard complies with UNECE Regulation No. 20.  |
