Producers and importers are given a twelve months transitional period to abide by the Standard.  This Standard applies to: <ul style="list-style-type: none"><li>a) Reversing lamps for vehicles of categories M, N, O, and T<sup>1</sup></li><li>b) Manoeuvring lamps for vehicles of categories M and N</li></ul> Worth mentioning is that this standard complies with UNECE Regulation No. 23.
