5.	<b>Title, number of pages and language(s) of the notified document:</b> Ministerial Decree No. 243/2016 mandating the Egyptian Standard ES 8012/2016 "Technical and environmental specification for ovens used for charcoal production" (12 pages, in Arabic)
6.	<b>Description of content:</b> The Ministerial Decree mandates that the producers and importers must comply with ES 8012/2016. Producers and importers are given a transitional period of six months to abide by the standard.  This standard is concerned with the technical and environmental specification for ovens used for charcoal production – with different techniques from one model to another, but with the same basic principles and rely on cooking isolated from the air in closed ovens – which meet the conditions and requirements of the industry, the environment, safety and occupational health.
