	<ul> <li>bulbs of the A, B, C, G, M, P, PS, PAR or R shapes*, or other bulb shapes where the lamps are intended to serve the same purpose as lamps with the foregoing bulb shapes;</li> </ul>
	<ul> <li>bulbs with all kinds of finishes;</li> </ul>
	<ul> <li>caps B15d, B22d, E12, E14, E17, E26, E26d, E26/50<sup>-1</sup>39, E27 or E27/51×39.</li> </ul>
