Description of content:** This decree mandates that the producers and importers of processed cheese and spreadable processed cheese with vegetable oils and fats must comply with the essential requirements and descriptive criteria for processed cheese and spreadable processed cheese with vegetable oils and fats as stated in ES1132/2014.

This standard supersedes the following Egyptian standards:

- 1. ES 1132-1/2005 "Processed cheese and spreadable processed cheese with vegetable oils and fats part 1: Processed cheese with vegetable oils and fats".
- 2. ES 1132-2/2005 "Processed cheese and spreadable processed cheese with vegetable oils and fats part 2: Processed cheese with vegetable oils and fats".
