- 5. Title, number of pages and language(s) of the notified document: Ministerial Decree No. 535 for the year 2015 mandating the application of Egyptian Standard ES 858 "Soap With Detergent for Household Purposes" (10 pages, in Arabic) to supersede ES 858/2007
- 6. Description of content: This Ministerial Decree mandates that the producers and importers of soap with detergent for household purposes must comply with ES 858. Producers and importers are given a transitional period of six months to abide by the standard.

This standard sets the requirements for the soap with detergent for household purposes.
